Ms. Leong is a member of the Hong Kong Institute of Certified Public Accountants and holds a bachelor degree in Accountancy.

The Board would like to take this opportunity to express its appreciation to Mr. Waung for his contribution to the development of the Company during his tenure as the Chief Financial Officer of the Company and look forward to the continued contribution from Mr. Waung and Ms. Leong to the Company in their new roles.
