**CLOSURE OF REGISTER OF MEMBERS
FOR FINAL DIVIDEND AND ANNUAL GENERAL MEETING**

Reference is made to the announcement of the final results for the financial year ended 31 December, 2016 made by Chinasoft International Limited (the “Company”) on 27 March, 2017 (the “Announcement”).

As mentioned in the Announcement, the board of directors of the Company (the “Board”) has recommended the payment of a final dividend of HK\$0.012 per ordinary share from share premium account of the Company in respect of the year ended 31 December, 2016 (the “Final Dividend”) to the holders of ordinary shares on the Register of Ordinary Shareholders of the Company (the “Register”) on 2 June, 2017. The Final Dividend is subject to approval by the shareholders of the Company at the upcoming annual general meeting of the Company (the “AGM”). The AGM will be convened to be held on Thursday, 18 May, 2017.

The Register will be closed during the following periods, and no transfers of shares will be effected during such periods:

- (i) from Monday, 15 May 2017 to Thursday, 18 May, 2017, both days inclusive, for the purpose of ascertaining shareholders’ entitlement to attend and vote at the AGM. In order to be entitled to attend and vote at the AGM, all transfers of ordinary shares of the Company, duly accompanied by the relevant share certificates, must be lodged with the Company’s branch registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, (the “Branch Registrar”) at Shops 1712-1716, 17th Floor, Hopewell Centre, 183 Queen’s Road East, Wan Chai, Hong Kong no later than 4:30 p.m. on Friday, 12 May, 2017; and

- (ii) from Wednesday, 31 May, 2017 to Friday, 2 June, 2017, both days inclusive, for the purpose of ascertaining shareholders' entitlement to the Final Dividend. In order to qualify for the Final Dividend, all transfers of ordinary shares of the Company, duly accompanied by the relevant share certificates, must be lodged with the Branch Registrar at the address set out above no later than 4:30 p.m. on Monday, 29 May, 2017.
