The operation of control equipment is more accurate, more convenient, and more stable, and truly realizes intelligent digitalization and intelligent management.

The smart central control panel of the whole house home appliance is the benchmark product in the field of smart home appliances after the Company signed a strategic cooperation agreement with SZ Kai Hong and Guochuang Center. This is an important achievement of the Company's continuous promotion of the in-depth application of the localized intelligent IoT operating system and capabilities in the field of smart home appliances.
